


RESOLUTION NO. 2023-03

THIS RESOLUTION adopted by the Board of Supervisors of Freedom Township in a duly authorized session, said Resolution stating as follows:



Adopted as a Resolution on this 13 day of September, 2023.



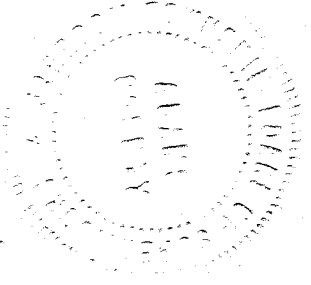

PARK PAVILION RENTAL FORM

PARK HOURS: Sunrise to sunset.

PARK AMENITIES: 24' x 36' handicapped accessible (ADA) picnic pavilion with 50x person maximum capacity. 1x charcoal grill. Six five-foot tables (two are ADA accessible); 1x cornhole game (ADA accessible. Bring your own bags); 1x horseshoe game (bring your own horseshoes); and parking for 25x vehicles. Electric vehicle charging station for 2x vehicles.

CONDITIONS OF USE:

1. Freedom Township (Township), its agents, and employees shall not be liable for any loss, damage, injuries, or other casualties of whatsoever kind or by whomsoever caused to the person or property of anyone on or off the premises, arising out of or resulting from the applicant's use, possession or operation thereof, or from defects in the premises whether apparent or hidden, or from the installation, existence, use, maintenance, condition, repair, alteration, removal, or replacement of any equipment thereof, or the applicant hereby agrees to indemnify, defend, and hold the Township, its agents, and employees harmless from and against all claims, demands, liabilities, suits, or actions for such loss, damage, injury, or other casualty.

2. Property damage to the facilities at the park caused by the participant/guest are the responsibility of the applicant who rented the pavilion.
3. No vehicles are allowed in the park.
4. No alcoholic beverages are allowed in the park.
5. All trash must be in trash bags and placed in the dumpster. Bring your own trash bags.
6. Reservations are not considered as confirmed until approved by the Township staff.
7. The applicant agrees that the \$100.00 deposit will be refunded only after a clean inspection of facilities by Township staff. The deposit will be retained if there is any damage and/or necessary clean up from the event. Additional fees will be the responsibility of the applicant for any damages of more than \$100.00.
8. Leashed pets are allowed with the provision that that all pet waste must be picked up.
9. No amplified music is allowed.
10. Parking allowed in designated spaces only. 25 spaces are available with 2 for electric vehicles and 3 that are handicapped accessible.
11. No water balloons, pools, dunk tanks, petting zoos, or pony rides are allowed in the park.
12. The grill is for charcoal only with the applicant's responsibility to bring their own charcoal.
13. Small signs may be placed on stakes in the ground (not on park signs).
14. Decorations may be tied with string—no nails, staples, or tape on tables or pavilion.
15. Remove all signs and decorations at the end of your event.
16. The park is closed and shall not be used from dusk to dawn.
