Call to Order

Chair Young called the Board of Supervisor's Meeting to order at 7:00 P.M.

Approval of Minutes

Vice-Chair Kellett made a **MOTION** to approve the Minutes of the June 12, 2024, regular meeting. The **MOTION** was **SECONDED** by Mr. Johnston. The motion carried unanimously (3-0).

Monthly Expenses

Vice-Chair Kellett made a **MOTION** to approve the bills in the amount of \$44,412.35 from the General Fund, \$718.68 from the Highway Aid Fund, and \$536.00 from the Escrow fund with the following condition:

1. \$25,000.00 donation to the Greenmount Fire Department only be released if approved at tonight's meeting under New Business.

The **MOTION** was **SECONDED** by Mr. Johnston. The motion carried unanimously (3-0).

Manager & Road Reports

Chair Young read the Manager's report. The Manager completed the following tasks in June:

Mr. Gulden stated that the Board budgeted \$50,000.00 in Liquid Fuel's money in 2024 for road projects, so they will need to approve a resolution at next month's meeting adding more money to the budget to complete a project.

B. Consider approval of \$25,000.00 budgeted donation to the Greenmount Community Fire Department for purchase of new tanker truck.

The Board expressed great concern with Greenmount's decision to purchase a new tanker truck for over \$500,000.00 instead of the original proposal of purchasing a used tanker truck for around \$100,000.00. They asked Greenmount to present a plan on how they will be able to afford the more expensive truck before providing the donation. Mr. Geleta & Mr. Buchheit stated they will prepare the requested plan.

Vice-Chair Kellett made a **MOTION** to table this item. The **MOTION** was **SECONDED** by Chair Young. The motion carried unanimously (3-0).

C. Consider approval of a memorandum of understanding between the County of Adams and Freedom Township regarding website services.
